## Purpose of processing - Legal basis of processing

Personal data are processed, as part of the activities of our Foundation established in application of the provisions of the "Declaration in the preamble to the CCNL 30.06.2008" and of the National Agreement 15.9.2010, for the purposes relating to the signing of the Urbino Charter. The legal basis for the processing is the performance of contractual obligations or the execution of pre-contractual measures also taken at the request of the data subject (Art. 6(1)(b) GDPR). In particular, filling in the subscription form will allow the Foundation to store the data indicated therein until a formal request for deletion. The provision of data is completely free and voluntary but necessary in order to allow the Controller to proceed with your request to subscribe to the Urbino Charter. ## Methods of data processing
